Property development player BLUELIFE Investments: CAUDAN drops to Rs0.98 (-2%), UTDL to Rs50 (-2%) dwindles to Rs0.99 (-1%) while sugar stock OMNICANE drops to Rs15 (-2.6%). Banking stocks end on contrasting performances with MCBG slightly up by 0.4% to Rs233 while SBMH contracts to Rs3.44 (-1.2%). CIM recovers from its weak Friday to Rs6.26 (+2%) on again 100 shares as SWANGEN regains 0.3% to Rs303. On the DEM, ABC Banking jumps to Rs16 (+3.2%) and SEMARIS loses to Rs1.10 (-1.8%).

The SEMDEX falls to 1,600.82 (-0.1%), with market value traded (MVT) amounting to Rs27.4m for a total volume traded (TVT) of 0.6m.


