LOTTO: Top gainer

Semdex 4 1,600.35 Sem-10 4 299.97 Demex 4 204.57

LOTTO finishes the session as the top performer at Rs8.60 (+4.9%) with 10.3k shares traded. The **SEMDEX** slightly inches down to 1,600.35 as index heavy constituents **SBMH** and **ROGERS** drag on performance. **SBMH** dips by 2.6% to Rs3.35 on large volumes of 1.1m units traded and **ROGERS** descends to Rs20.50 (-2.4%) on 7.8 shares. **MUA** jumps by 1.4% to Rs90.25 on 100k shares and POLICY appreciates to Rs3.70. **POLICY** published its NAV as at 30 Nov 2020 at Rs4.97 per share. **BLUELIFE** recovers to Rs1 (+1%). The **DEM** finishes on a negative note with ABC contracting to Rs15.50 (-3.1%) and **LAVASTONE** to Rs1.55 (-3.1%).


The SEMDEX falls to 1,600.35 (-0.03%), with market value traded (MVT) amounting to Rs22.2m for a total volume traded (TVT) of 2.1m.

Foreign Investors (FI) are seller with FIS of Rs5.3m vs FIP of Rs0.3m.

Investments: FINCORP drops to Rs17.55 (-2.5%) and CAUDAN to Rs0.96 (-2%). TERRA appreciates to Rs19.10 (+0.3%), ALTEO to Rs19.60 (+0.5%) and CIEL to Rs3.50 (+2.9%).

International equity markets: The FTSE 100 finished in the red as it emerged London would be placed into the strictest COVID tier as of Wednesday.
