Stock market dips slightly

The SEMDEX dips slightly as finance and investment stocks drag the Leisure: LOTTO mounts to Rs9.40 (+5.2%). index down during a shorter session closing at 12.00 pm instead of 2.30 pm. MCBG falls to Rs238 (-0.4%) on 218k shares. FINCORP tumbles to Rs18 (-2.7%), UTDL to Rs50 (-1%), MDIT to Rs2.33 (-0.4%) and International equity markets: The S&P 500 closed little changed on ascending to Rs5.26 (+1.2%) and **SUN** to Rs13.75 (+3.8%).
