## Finance stocks in focus

Semdex 1.642.14 Sem-10 214.83 **Demex** 308.20

**SEMDEX**. **MCBG** finishes up at Rs237 (+0.4%) on 29k shares as its Rs0.2m. peers SBMH drives up by 3.5% to Rs3.52. CIM progresses with its ascent closing at Rs6.42 as the financial services group freshly releases its financial results for the year ending 30 Sep 2020. The Group's Net Operating Income from continuing operations increased (+15%) to reach Rs2.1bn whilst PAT decreased by 50% to Rs90.8m overall for the year under review. primarily due to an increase in allowance for credit impairment to reach Rs652.6m (FY19: Rs180.9m) due to the uncertain economic outlook. After a one-day rise, IBL steps back to Rs47.50 the month at Rs4.75. On the DEM, banking stock ABC also flashes up by 2.9% to Rs18 on simply 100 units as UTIN soars by 6.6% to Rs4.50.

The SEMDEX rises to 1,6142.14 (+0.3%), with market value traded (MVT) amounting to Rs26.2m for a total volume traded (TVT) of 1.3m.

Finance stocks, together with investment stocks, tilt up and fuel the Foreign Investors (FI) are buyer with FIP of Rs I.5m and FIS of


