
The SEMDEX slows down its progression as major stocks stay Industry: MCFI climbs to Rs12.45 (+0.4%). unchanged. Finance stocks stay largely still with only MUA rising up to Investments: MDIT falls to Rs2.25 (-4.3%) and CIEL falls to Rs3.12. Rs88.50 (+2.9%) on simply 100 shares. Biggest gainer for the day is TERRA mounts to Rs18.75 (+0.8%), POLICY to Rs3.80 (+2.7%) and GRIT advancing further to USD0.75 (+5.6%) on mere 600 shares FINCORP up at Rs16 (+2.9%). exchanged. Sugar stock OMNICANE climbs to Rs13.90 while leisure Leisure: LOTO falls to Rs7.42 (-0.8%). stock LOTTO retracts to Rs7.44 (-0.8%). The DEM strengthens on the basis of three movers being LMLC surging the most by 8% to International equity markets: The S&P 500 bounced up after a Rs270, ABC Banking tilting up to Rs15.55 (+1.3%) and PCON choppy session, as hopes of a COVID-19 vaccine have increased inching to Rs27.25 (+0.9%).

The SEMDEX rises to 1,569.43 (+0.1%), with market value traded (MVT) amounting to Rs38.3m for a total volume traded (TVT) of 1.4m.
