SUN shines bright

Semdex J,477.94 Sem-10 n 273.41 Demex J95.66

The stock market ends the day with negative sentiment prevailing over banking stocks while hotel stocks realise good gains. **SUN** jumps as high as 8.8% to Rs15.50 on 900 shares while its peer **NMH** puts on 1.6% to finish at Rs5.20. On the same theme, **NMHPREF** appreciates to Rs9.04 (+0.2%) on 2.3k shares. Banking giant **MCBG** inches down to Rs205 (-0.5%) as **SBMH** dips to Rs85 (-1.2%). **MUA** rights drop to Rs2 (-33%). Outgoing SEM-10 constituent, **MEDINE**, falls deeply by 8.8% to Rs30 on 8.8k shares. In terms of recovery, **ENL** departs from its all-time low status and mounts to Rs13.5 (+3.8%) and **ROGERS** posts slight gains to Rs20.70 (+2%). On the **DEM**, **CHSL** tanks by 7.7% to Rs12 while **EUDCOS** moves south to Rs9.90 (-1%).

The SEMDEX drops to 1,477.94 (-0.1%), with market value traded (MVT) amounting to Rs I 1.6m for a total volume traded (TVT) of 0.8m.

Foreign Investors (FI) are seller with FIS of Rs4.7m vs FIP of Rs0.09m.

Commerce: INNODIS appreciates to Rs43 (+0.1%).


Industry: GAMMA rises to Rs26.05 (+0.2%) while MOROIL drops to Rs20 (-4.1%).

Investments: POLICY dips to Rs3.90 (-2.5%) and FINCORP dips to Rs15.60 (-2.5%).

International equity markets: The FTSE 100 ended the day broadly flat, as Rishi Sunak replied he aims at saving jobs when asked about the possibility of tax rises to pay for the soaring cost of the coronavirus.
