OMNICANE gets sugar rush

Semdex 1,655.50 Sem-10 OMNICANE jumps by 3.9% to Rs16, its seven months high, on 40k Foreign Investors (FI) are seller with FIS of Rs25.2m and FIP of shares exchanged. The sugar stock is on its second day rise for the Rs11.5m. month of January as trading volumes picks up. Construction stocks GAMMA and UBP collectively finish green as GAMMA escalates to Rs32 (+1.9%) and **UBP** ascends to Rs121.25 (+0.6%). Finance stocks close the session unchanged while worth mentioning SBMH closes flat to Rs15.40 (+1.7%), **ALTEO** to Rs21.75 (+2.4%) and **FINCORP** to Rs18.50 (+2.8%). Focussing on the **DEM**, albeit at a slower pace, **C**-CARE still presses on the positive momentum to Rs10.40 (+2%) as ASCENCIA strengthens to Rs19.50 (+2.6%) while ABC Banking dips to Rs I 6.80 (-4%).

The SEMDEX rises to 1,655.50 (+0.03%), with market value traded (MVT) amounting to Rs32.2m for a total volume traded (TVT) of 1.0m.

Industry: PBL falls to Rs590 (-0.2%).



International equity markets: The S&P 500 fell 0.7%, snapping a four-day winning streak as Tesla, Amazon, Apple and other big gainers over the past year led the way lower.
