MEDINE has the wind in its sails



MEDINE gets another boost to Rs38.90 (+14.1%), its one-month high, Finance: SWANGEN weakens to Rs303 (-0.7%). yet on just 700 shares exchanged. LUX shakes off economic outlook and willingness to maintain low rates boost major US 2% to Rs24 as **BLUELIFE** shrinks to its three-months low at Rs0.91 (- stock indices on Wednesday, with the Dow and S&P 500 closing at 1.1%). On the DEM, C-CARE contracts to Rs10.35 (-0.5%) as records. ASCENCIA still continue to attract large chunks of 244k shares exchanging hands, yet the majority of which traded at current price of Rs20.50.

The SEMDEX recovers to 1,563.07 (+0.4%), with market value traded (MVT) amounting to Rs33.6m for a total volume traded (TVT) of 1.0m.
