VIVO pushes further modestly higher with tech-stocks bouncing back from a recent sell-off to its 3-month highest at Rs225 (+0.1%). OMNICANE manages to trend triggered by an upsurge in US Treasury bond yields. recover to Rs14 (+0.7%). GAMMA dips to Rs32 (-0.2%) on 156k shares as its activity levels peak over 3-month period. The **DEM** finishes all green as Happy World Property reaps in the highest gain of 5.6% to Rs9.50, followed by ABC Banking to Rs15.35 (+1.7%) and **ASCENCIA** to Rs21.25 (+1.9%).

The SEMDEX rises to 1,570.13 (+0.3%), with market value traded (MVT) amounting to Rs17.4m for a total volume traded (TVT) of 0.5m.
