Property stocks close in the green territory

2,062.33 372.56 Demex 266.20 The **SEMDEX** moves lower by -0.1% to end this week's session at Sugar: **OMNICANE** slips to Rs22.00 (-3.9%).


Investments: ALTEO falls to Rs10.05 (-3.4%), CIEL retreats to Rs6.96 (-0.6%), ENL inches up to Rs20.25 (+0.3%), FINCORP Rs16.00 (-2.7%), NIT up to Rs18.00 (+3.5%).

Leisure & Hotels: LUX advances to Rs56.50 (+0.4%), SUN gains +0.4% to close at Rs38.15 on 4.1k units.

GRIT (USD) closes higher at USD0.29 (+3.6%) on 1k units.

International equity markets: US equities closed mixed following the release of the Fed's preferred gauge of inflation, the Core Personal Consumption Expenditures (PCE) index. The inflation print for the month of October showed that prices rose by 3.5% year-over-year (September: 3.7%). Inflation in the US seems to be on the downtrend, nevertheless economists are expecting it to Commerce: INNODIS moves lower to Rs35.05 (-0.3%), VIVO remain sticky over the coming months. The S&P 500 inched up by +0.4%, the Dow Jones Industrial Average (^DJI) added +1.5%, while Nasdaq slipped by -0.2%.
