International equity markets: US equities reversed Friday's

gains with investors awaiting the release of key labor-market figures.

It is expected that the unemployment rate in the US will remain unchanged at 3.9% in November. The S&P 500 inched lower by -

0.5%, the Dow Jones Industrial Average (^DJI) down by -0.1% and Nasdaq fell by -0.8%. The Caixin China Services Purchasing Managers Index (PMI) rose to 51.5 in November, beating estimates

of 50.5 and showing that the services sector has expanded for the

Domestic indices move lower

The **SEMDEX** slips by 3.54 points to close at 2,061.17 (-0.2%) with market value traded (MVT) amounting to Rs26.0m for a total volume traded (TVT) of 2.0m. The **SEM-10** declines by -0.7% to end at 369.92 and is currently down by -0.8% year-to-date. The **DEMEX** inches down to 266.24 (-0.1%).

Finance: MCBG falls further to Rs326.00 (-0.6%) on 19.1k units.

Commerce: IBL inches down to Rs44.95 (-0.1%) on 12.8k units.


