The **SEMDEX** takes another fall

Semdex 1,987.08 Sem-10 361.04 Demex 260.10

finishes slightly lower at 1,987.08 (-0.3%). BLL drops to Rs0.62 (-4.6%) on 18.0k units, ALTEO inches down to Rs.9.00 (-2.0%) and MDIT closes lower to Rs2.10 (-2.8%) on 35.9k units. Industry stock UBP International equity markets: U.S. stocks recovered following the recovers slightly to Rs105.00 (+2.2%). Leisure & Hotels stock SUN slips further to Rs27.75 (-0.9%). On the DEM, ATTITUDE rises to Rs10.40 (+0.5%), while **LAVA** inches down to Rs2.26 (-2.2%) and **PHIN** closes lower to Rs367.75 (-0.1%).

The SEMDEX slips further to 1,987.08 (-0.3%), with market value traded (MVT) amounting to Rs25.8m for a total volume traded (TVT) of 2.0m.

Foreign Investors (FI) are seller with FIS Rs2.6m and FIP Rs0.2m.

Domestic markets plummet lower for three days straight. **SEMDEX** Investments: PAD rises to Rs101.50 (+0.3%), whilst UNDL declines to Rs55.00 (-0.9%).

> rollout of the US CPI print for the month of February. Headline CPI increased to 6.0%, as expected by the market. Banks stocks jumped higher after having gone through a bloodbath driven by the SVB debacle. The S&P 500 picked up by +1.3%, the Dow Jones Industrial Average (^DJI) advanced by +1.0%, and NASDAQ rose by +2.0%.
