Property stocks end in the green

Semdex 1,947.72 Sem-10 355.12 Demex 251.58

Domestic markets finish today's session higher. The SEMDEX inches Foreign Investors (FI) are buyer with FIS Rs0.4m and FIP Rs0.9m upwards to 1,947.72 (+0.03%). Finance stocks ended mixed with MCBG rising further to Rs312.25 (+0.1%) on 22.2k units, SWAN GENERAL Investment stocks: BMH down to Rs21.50 (-1.2%), CIEL recovers moves up to Rs451.25 (+0.1%) and SBMH inches down to Rs4.51 (- to Rs6.16 (+0.3%) on 580.4k units, ENL down to Rs19.75 (-0.3%), 1.7%) on 100.2k units. Industry stock UBP moves down to Rs111.00 (- FINCORP down to Rs15.00 (-0.7%), MDIT down to Rs1.98 (-1.0%) 0.2%). Property stocks **ASCENCIA** rises to Rs20.95 (+0.2%) on 37.3k and **POLICY** recovers to Rs2.60 (+1.2%). units and BLL moves up to Rs0.56 (+5.6%). Leisure & Hotel stocks ended mixed with NMH down to Rs8.16 (-0.2%) on 38.4k units and LUX up to Rs47.00 (+3.8%) on 27.1k units. On the DEM, TPL (Ord) jumps Rs3.90 (+14.7%), C-CARE moves up to Rs9.30 (+2.2%), PHIN declines to Rs310.00 (-1.9%) and LAVA slips further to Rs1.87 (-3.6%) on 41.0k units.

The SEMDEX inches higher to 1,947.72 (+0.03%), with market value traded (MVT) amounting to Rs23.8m for a total volume traded (TVT) of 1.3m.

International equity markets: US markets closed lower following the release of the CPI figures by the US Bureau of Labour Statistics. US Headline CPI for the month of April rose by 4.9% year-over-year. Core US CPI was up by 5.5% year-over-year. The S&P 500 slipped by -0.6%, the Dow Jones Industrial Average (^DJI) declined by -0.7%, and NASDAQ was down by -0.6%.
