### NMH features as top gainer for the day

2,078.18 Semdex The **SEMDEX** advances by 6.83 points to close at 2,078.18 (+0.3%) Foreign Investors (FI) are net sellers with FIS amounting to with market value traded (MVT) amounting to Rs100.3m for a total volume traded (TVT) of 4.2m. DEMEX inches down to 271.87 (-0.01%).

NMH jumps by +4.3% to record its sixth straight winning-streak at Rs12.25 on 82.3k units. The stock is gradually moving closer to the recent high of Rs12.85 and tops the year-to-date best performers'

Finance: CIM rises to Rs10.95 (+0.5%) on 2k units. MCBG maintains its winning streak as it closes higher at Rs335.00 (+0.9%) on 23.1k units. SBMH moves lower by -0.2% to close at Rs4.44 on 111.3k units.


Leisure & Hotels: SUN slips further to Rs37.10 (-0.8%) on 66.2k units.

Investments: ALTEO moves up to Rs10.35 (+0.5%), ENL edges lower to Rs20.50 (-1.7%), MSE reverses losses and rises to Rs50.75 (+0.5%), **PAD** inches down to Rs105.00 (-0.5%).

International equity markets: US stocks closed in the green territory, with markets digesting the release of further earnings. US Brent Crude oil fell to \$79.54/barrel, below the recent peak of \$96/barrel following the Israel-Hamas war. According to the CME FedWatch tool, markets are expecting that the Fed will not raise interest rates this year and they anticipate that rate cuts will begin in the second half of 2024. The S&P 500 inched up by +0.1%, the Dow Jones Industrial Average (^DJI) down by -0.1% and Nasdaq added +0.1%.
