

# Stock Market Update

## **November 15, 2023**

#### MCBG up +10.7% year-to-date

The SEMDEX adds 3.08 points to finish today's session at 2,093.97 Foreign Investors (FI) are net buyers with FIS amounting to (+0.2%) with market value traded (MVT) amounting to Rs33.6m for à total volume traded (TVT) of 1.0m. The **DEMEX** inches up to 272.07 (+0.1%).

MCBG rises by +0.3% to close at a one-month high of Rs340.00. Total value traded for the day amounts to Rs21.9m, accounting for 65.2% of MVT. It is currently trading at a PE of 5.9x and is up by +10.7% year-to-date.

Finance: SBMH reverses yesterday's gains and declines to Rs4.58 (-0.4%) on 511.3k units.

Industry: MOROIL jumps by +4.4% to Rs17.75 on only 0.2k units.

Leisure: LOTO slips to Rs7.16 (-0.6%), NMH rises to Rs11.00 (+0.9%) on 14.9k units.


Investments: CAUDAN Rs0.53 (-1.9%), CIEL edges higher to Rs6.84 (+0.6%) on 71.9k units, ENL slips to Rs20.50 (-0.5%) on 97k units, POLICY Rs3.00 (+1.4%), ROGERS gains +1.3% to close at Rs32.00 on 0.9k units, UTDL Rs55.50 (+0.9%).

International equity markets: US equities registered broad based gains across sectors following the release of the CPI figures for the month of October by the Bureau of Labour Statistics. The US Core Consumer Price Index (CPI) came at a two-year low of 3.2% y/y, below expectations of 3.3%. ÚS retail sales will be released

later today and is expected to show a month-over-month decline of 0.3%. The S&P 500 added +1.9%, the Dow Jones Industrial Average (^DJI) gained +1.4% and Nasdaq jumped by +2.4%.
