## MCBG extends its winning streak

Value Traded (MVT) for the day amounts to Rs35.7m, with volume traded of I.Im.

Foreign investors are net buyers with Foreign Investor Purchases (FIP) Leisure & Hotels: LOTO declines further to Rs5.40 (-1.8%), SUN drops to Rs40.60 (-1.0%).

MCBG rises for the fifth consecutive session to close today's session at Rs386.75 (+0.1%). Value traded for the day amounts to Rs18.8m, accounting for 52.6% of MVT. FIP amounts to Rs8.5m, compared to FIS of Rs2.6m. The stock is currently up by 19.4% year-to-date.

Finance: MCBG Pref retreats to Rs10.20 (-0.5%), SBMH closes lower at Rs4.79 (-0.2%).

Commerce: IBL declines to Rs40.00 (-0.5%).

Industry: GAMMA inches lower to Rs29.85 (-0.2%).
