Foreign investors are net sellers with Foreign Investor Purchases (FIP) of Rs1.6m, compared to Foreign Investor Sales (FIS) of Rs5.2m.

NMH advances near its one-month high of Rs11.90, closing the Property: BLL drops to Rs0.48 (-2.0%). session at Rs11.85 (+3.0%). Value traded for the day amounts to Rs5.3m, accounting for 26.0% of MVT. Its current dividend yield stands at 4.2% and it is up by +6.8% year-to-date.
