Foreign investors are net sellers with Foreign Investor Purchases (FIP) of Rs0.2m, compared to Foreign Investor Sales (FIS) of Rs0.3m.

SEM-10, consisting of the 10 largest companies by market capitalization, closes at 413.12 points (+0.3%). The index posts a year-to-date return of 12.6%, mostly driven by strong gains from banking stocks.

Finance: MCBG extends its gains as it closes higher at Rs405.75 (+0.4%), with value traded for the day amounting to RsI3.6m. SBMH maintains the uptrend, finishing the session at Rs5.28 (+1.5%)

The SEMDEX advances to 2,191.17 (+0.3%). Market Value Traded Information, Communication & Technology: EMTEL closes (MVT) for the day amounts to Rs33.5m, with volume traded of unchanged at Rs21.50, with value traded for the day amounting to Rs1.5m.

Industry: UBP falls further to Rs81.00 (-0.6%).

Investments: ALTEO Rs11.25 (+4.7%), CIEL Rs7.94 (+0.3%), MDIT Rs1.70 (+1.2%) NIT Rs10.75 (-0.5%), UTDL Rs58.50 (+0.9%).

Leisure: NMH adds +1.2% to close at Rs12.80, NMH Pref inches lower to Rs10.75 (-0.5%), LUX advances to Rs54.50 (+0.5%).

Property: ASCENCIA rises to Rs17.50 (+0.3%), BLL moves up to Rs0.50 (+2.0%).

Sugar: OMNICANE closes at Rs19.00 (+0.3%).
