SBMH edges lower to Rs5.20

SBMH closes lower at Rs5.20 losing 0.4% during today's session. Volume traded for the day amounts to 257k shares, equivalent to Rs1.3m in value. Year-to-date, the banking stock registers a positive performance of 14.3% advancing from closing price of Rs4.55 on 29th Dec 2023.

Foreign Investors (FI) are net sellers with FI Sales (FIS) of Rs12.1m against FI Purchases (FIP) of Rs0.1m. CMSF STRUCT NOTE accounts for 85.9% (Rs10.4m) of FIS.

Financial Services: MCBG gains 0.6% to Rs443.

Commerce: VIVO inches up 0.1% to Rs353.75.

Investments: CIEL gains 1.1% to Rs9.10 while POLICY drops to Rs4.40 (-2.2%), CAUDAN to Rs0.57 (-1.7%), MDIT to Rs1.83 (-0.5%), FINCORP to Rs18 (-0.3%) and ENLG to Rs23.65 (-0.2%).
