PHIN accounts for 7.73% of today's market activity (Rs77.3m). During the session, 14.7K shares were exchanged on the Investement stock representing Rs 5.9m purchases, emanating from local investors. After trading in a range of Rs409 (intraday high) and Rs 405 (intraday low), PHIN closes the day at Rs 409 increasing 2.51 % day-on-day.

Foreign Investors (FI) are net sellers with FI Sales (FIS) of Rs1.5m compared to FI Purchases (FIP) of Rs0.3m.

Financial Services: MCBG closes higher at Rs 443.25 (0.17%).


