

### ALTEO trades ex-dividend at Rs10.40

The **SEMDEX** inches lower by 3.58 points to close at 2,110.29 (-0.2%). Market Value Traded (MVT) for the day amounts to Rs20.6m, with volume traded of 0.7m.

Foreign investors are net buyers with Foreign Investor Purchases (FIP) of Rs0.6m.

**ALTEO** trades ex-dividend at Rs10.40 (-8.4%) with value traded for the day amounting to Rs1.6m. The company had announced a final dividend per share of Rs0.63, which will be payable on or around 26 July 2024. Its current dividend yield stands at 6.1%.

**Finance: CIM** rises to Rs10.50 (+1.0%), **MCBG Pref** advances to Rs10.30 (+3.0%), **MUA** closes lower at Rs57.75 (-0.4%).

**Commerce: INNODIS** retreats to Rs30.30 (-0.3%), **IBL** declines by -0.5% to close at Rs40.30.

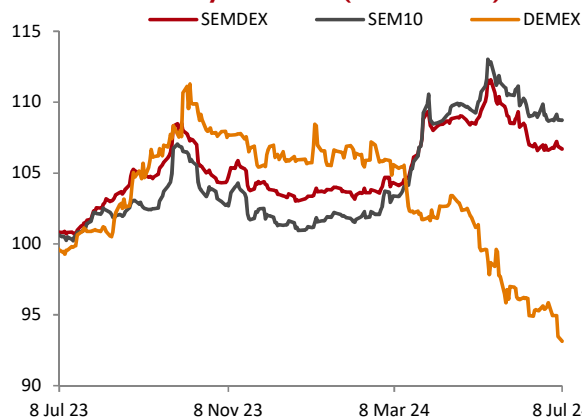
**Information, Communication & Technology: EMTEL** falls to Rs23.20 (-1.1%) with value traded for the day amounting to Rs1.2m.
