

MCBG extends its winning streak

The **SEMDEX** closes today's session at 2,107.98 (+0.01%). Market Value Traded (MVT) for the day amounts to Rs26.2m, with volume traded of 0.2m.

Foreign investors are net sellers with Foreign Investor Purchases (FIP) of Rs8.4m, compared to Foreign Investor Sales (FIS) of Rs9.0m.

MCBG extends its winning streak for the fifth straight session as it adds +0.1% to close at Rs382.50. Value traded for the day amounts to Rs17.2m, accounting for 65.9% of MVT. FIP amounts to Rs4.8m, compared to FIS of Rs7.1m. The stock is currently up by +18.1% year-to-date.

Information, Communication & Technology: EMTEL inches lower to Rs22.80 (-0.2%).

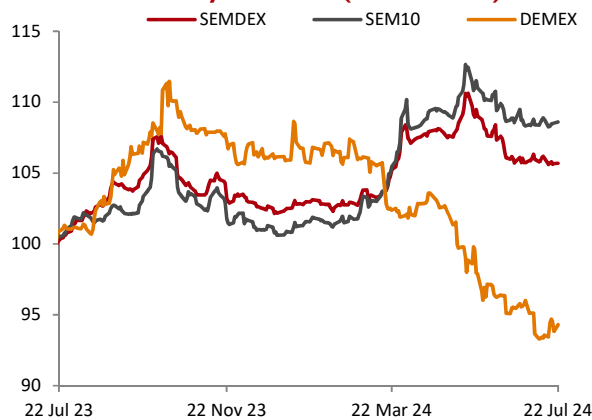
Industry: UBP falls to Rs84.00 (-0.3%).
