

### LOTO announces an interim dividend per share of Rs0.14

The **SEMDEX** closes nearly unchanged at 2,105.51 (+0.01%). Market Value Traded (MVT) for the day amounts to Rs18m, with volume traded of 0.4m.

**Finance: MCBG** edges higher to Rs384.00 (+0.4%), with value traded for the day amounting to Rs11.6m. **SBMH** inches up to Rs4.71 (+0.2%).

Foreign investors are net sellers with Foreign Investor Purchases (FIP) of Rs0.3m, compared to Foreign Investor Sales (FIS) of Rs1.3m.

**Industry: PIM** edges higher to Rs37.00 (+4.2%), **GAMMA** retreats to Rs28.10 (-1.4%), **MOROIL** rises to Rs16.50 (+0.6%).

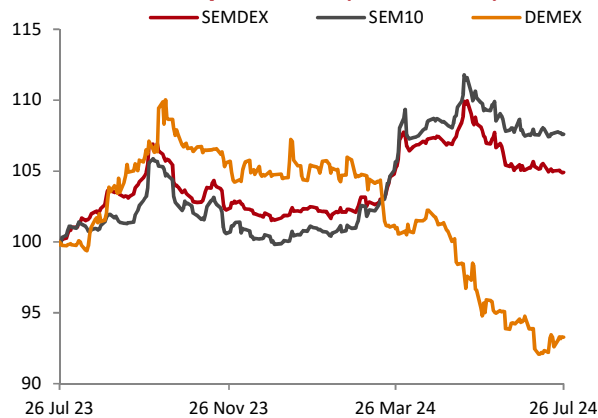
**LOTO** published its earnings for the 6 months ended 30 June 2024. Top line performance for the half-year declined to Rs679.6m (-12.3% y/y) and PAT amounted to Rs50.9m (-40.2% y/y), resulting from lower aggregate jackpots. The company announced an interim dividend per share of Rs0.14, which will be paid on or about 25 September 2024. The shares will trade ex-dividend as from 12 August 2024. The stock rises by +1.5% to close today's session at Rs5.46.
