SBMH leads volume traded for the day

Semdex 2,108.26 Sem-10 395.21 **Demex** 238.24

Market Value Traded (MVT) for the day remains tepid at Rs24m, at Rs22.25 (+1.1%). with volume traded of 3.2m.

Foreign investors are net sellers with Foreign Investor Purchases (FIP) of Rs7.0m, compared to Foreign Investor Sales (FIS) of Rs I 3.2m.

SBMH features as most active stock in terms of value traded for the day, accounting for 52.3% of MVT. FIP amounts to Rs7.0m, compared to FIS of Rs12.5m. The stock closes unchanged at Rs4.71 on 2.7m units. Its 52-week price range lies between Rs4.38 and Rs5.20.

Finance: CIM edges higher to Rs10.50 (+1.0%).

Industry: GAMMA moves up to Rs29.50 (+5.0%), MOROIL maintains the uptrend as it rises further to Rs16.70 (+1.2%).
