### MCBG rises to one-month high

Semdex 2,111.69 Sem-10 395.96 **Demex** 238.84

The **SEMDEX** adds meagre gains of 3.43 points to close at 2,111.69 (+0.2%). Market Value Traded (MVT) for the day amounts to Rs32.6m, with volume traded of 0.5m.

Foreign investors are net buyers with Foreign Investor Purchases (FIP) of Rs24.4m, compared to Foreign Investor Sales (FIS) of Rs3.7m.

MCBG gains +0.1% to close at a one-month high of Rs384.50. Value Rs7.46 (+1.4%). traded for the day amounts to Rs27.8m, accounting for 85.3% of MVT. FIP amounts to Rs23.3m, compared to FIS of Rs3.0m. Its market capitalization currently stands at Rs98.2bn, with a year-to-date return of 18.7%.

Finance: MCBG Pref closes lower at Rs10.25 (-0.5%), CIM rises to Sugar: OMNICANE falls to Rs19.00 (-1.3%). Rs10.55 (+0.5%).

Commerce: IBL moves up to Rs40.10 (+0.3%), SHEL inches lower to Rs348.00 (-0.6%).

Industry: GAMMA declines to Rs29.45 (-0.2%), PBL advances to Rs493.00 (+0.2%).

Information, Communication & Technology: EMTEL rises further to Rs22.50 (+1.1%).
