The **SEMDEX** rises by 9.4 points to finish at 2,122.90 (+0.5%). Market Value Traded (MVT) for the day amounts to Rs27.6m, with volume traded of 1.2m.

Foreign investors are net sellers with Foreign Investor Purchases (FIP) of Rs2.8m, compared to Foreign Investor Sales (FIS) of Rs5.0m.
