## MCBG extends its winning streak

2,406.54 449.22 Semdex Sem-10 The **SEMDEX** picks up by 9.01 points to close this week's session at

2,406.54 (+0.4%). Market Value Traded (MVT) for the day amounts to Rs I 5.0m, with volume traded of 0.9m.

Foreign investors are net sellers with Foreign Investor Sales (FIS) of Rs3.2m, compared to Foreign Investor Purchases (FIP) of Rs1.5m.

MCBG maintains the uptrend as it rises further by +0.9% to close today's session at Rs450.00. Value traded for the day amounts to Rs9.3m, accounting for 62.4% of MVT. The stock is currently up by 38.9% year-to-date, with a market capitalization of Rs I I 5bn.

Finance: SBMH breaks its losing streak to close slightly higher at Rs5.66 (+1.4%).

Information, Communication & Technology: EMTEL closes unchanged at Rs21.60.


