## SBMH closes lower at Rs5.74

The **SEMDEX** inches lower to 2,408.93 (-0.1%). Market Value Traded (MVT) for the day remains tepid at Rs15.5m, with volume traded of 0.7m following a technical issue which delayed the opening session.

Foreign investors are net sellers with Foreign Investor Sales (FIS) of Rs5.2m, compared to Foreign Investor Purchases (FIP) of Rs0.03m.

**SBMH** closes lower at Rs5.74 (-2.1%), with value traded for the day of Rs0.2m. The Group recently published its earnings for the 9 months ended 30 September 2024. Its Operating income rose by 4.0% to Rs12.5bn, driven by an increase in both net interest income and non-interest income. PAT attributable to owners of the company declined slightly to Rs4.0bn (-0.8%) due to changes in taxes and levies. Its gross NPL ratio improved to 6.1% and the Capital Adequacy Ratio (CAR) stood at 20.5%. Today, SBMH announced the resignation of Mr. Hajee Abdoula as Group


