The **SEMDEX** inches up by 8.02 points to close at 2,397.47 (+0.3%). Market Value Traded (MVT) for the day amounts to Rs32.6, with volume traded of 2.3m.

Foreign investors are net sellers with Foreign Investor Sales (FIS) of Rs3.9m, compared to Foreign Investor Purchases (FIP) of Rs3.3m.

MCBG rises to Rs443.00 (+0.3%), with value traded for the day amounting to Rs8.3m. The Group has announced a share conversion price of Rs425.74 for holders of Preference Shares who may exercise their option to convert any or all of their preference shares into ordinary shares.

Commerce: IBL declines to 52-week low of Rs39.30 (-0.5%), **INNODIS** moves lower to Rs28.50 (-0.7%).

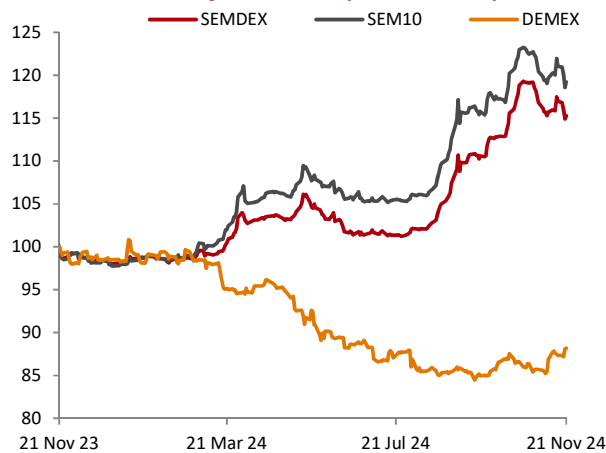
Information, Communication & Technology: EMTEL falls to Rs21.60 (-0.7%).
