IBL falls near 7-year low

2,381.41 Semdex Sem-10 Value Traded (MVT) for the day amounts to Rs95.7m, with volume traded of 2.6m.

Foreign investors are net buyers with Foreign Investor Sales (FIS) of Rs I.8m, compared to Foreign Investor Purchases (FIP) of Rs49.3m.

IBL maintains the downtrend and closes near 7-year low at Rs37.80 (-0.5%). Value traded for the day amounts to Rs0.4m. The stock is currently down by 12.3% year-to-date, with a market capitalization of Rs25.7bn.


