The SEMDEX opens this week's session nearly unchanged at 2,352.54 (+0.01%). Market value traded (MVT) for the day remains subdued at Rs7.7m for a total volume Leisure & Resorts: LOTO advances to Rs4.48 (+5.4%), NMH inches up to Rs12.55 traded of 0.2m. Since the start of April, the index declined nearly 5.3%, amid traderelated volatility tied to policy shifts under the Trump administration. The top five year-to-date performers on the Official market as at today's close are as follows: , SBMH (+20.1%), UTDL (+18.7%), NEWGOLD ETF (+16.7%), PBL (+14.4%), PIM (+13.8%).

Foreign Investors (FI) are net sellers with FI Purchases (FIP) of Rs0.2m against FI Sales (FIS) of Rs3.9m.


