

MCBG ends this week's session at Rs448.50

The SEMDEX ends this week's session lower by 10.67 points to close the session at Industry: MOROIL adds +3.0% to close at Rs17.00. 2,374.50 (-0.5%). Market value traded (MVT) for the day amounts to Rs37.4m for a total volume traded of 2.5m.

Foreign Investors (FI) are net buyers with FI Purchases (FIP) of Rs17.5m against FI Sales (FIS) of Rs4.9m.

MCBG ends this week's session lower at Rs448.50 (-0.1%). Value traded for the day amounts to Rs21.1m accounting for 56.3% of total market turnover. Foreign investor purchases amounts to Rs12.9m compared to foreign sales of Rs3.2m. At the current price level, its market capitalization stands at Rs I 16.4bn.

Commerce: IBL falls to Rs31.00 (-0.2%).


