

# **Stock Market Update** May 20, 2025

## SBMH pulls back 7.1% on ex-dividend date

Semdex 2,422.12 Sem-10 451.85 **Demex** 226.03

The SEMDEX declines by 9.85 points to close the session at 2,422.12 (-0.4%). Market value traded Sugar: OMNICANE gains +5.3% to close at Rs19.00. (MVT) for the day amounts to Rs35.8m for a total volume traded of 1.8m.

Foreign Investors (FI) are net sellers with FI Purchases (FIP) of Rs3.9m against FI Sales (FIS) of Rs5.8m.

SBMH pulls back by -7.1% to close at Rs5.80, marking its first dip below Rs6.00 in 28 sessions. The stock trades ex-dividend today with value traded of Rs5.7m and muted foreign participation of Rs0.1m. At the current price level, the stock trades at a PE of 3.5x and offers an 8.6% dividend yield. Its market capitalisation stands at Rs I 7.6bn.

Finance: MCBG edges lower to Rs466.50 (-0.1%) on 27k units.


Investments: ENL Rs29.45 (-0.5%), TERRA Rs22.50 (+1.6%).
