## Dividend-led upside: SUN gains +10.8%

The **SEMDEX** inches up by 2.72 points to close at 2,414.60 (+0.1%). Market value traded (MVT) for the day amounts to Rs40.2m for a total volume traded of 1.5m.

Foreign Investors (FI) are net sellers with FI Purchases (FIP) of Rs0.2m against FI Sales (FIS) of Rs4.8m.

**SUN** advances by +10.8% to close at Rs41.00, breaching the Rs40.00 mark for the first time in over a month and emerging as the session's top performer. Value traded for the day amounts to Rs0.4m. The company declared a dividend per share of Rs2.60 yesterday. The dividend will be paid around 21 Jul 2025 and the stock will trade ex-dividend as from 10 Jun 2025. At the current price level its market capitalization and dividend yield stand at Rs8.0bn and 6.3% respectively.


Finance: MCBG inches lower to Rs461.75 (-0.1%) on 15.0k units.
