### **SEMDEX** slides to **YTD** low

low as investors continue to digest the recently announced fiscal measures. Market value traded for SUN declines to Rs37.00 (-13.9%). the day stands at Rs86.8m on a total volume of 1.9m shares. Foreign investors remain active, contributing 43.5% of today's turnover and closing as net sellers, with sales of Rs49.1m against GRIT (USD) drops to USD0.06 (-14.3%) on 10k units. purchases of Rs26.4m. Since the start of the week, the benchmark index has shed close to Rs7.5bn in market value, with total market capitalisation now at Rs308bn.

The SEMDEX declines by 28.15 points to close at 2,313.93 (-1.2%), marking a fresh year-to-date Leisure & Hotels: NMH closes lower at Rs12.45 (-0.4%) with value traded amounting to Rs4.5m,

Finance: MCBG extends its losing streak, closing the session at Rs430.00 (-1.2%). CIM falls to Rs15.90 (-0.3%), SBMH adds +1.4% to finish at Rs5.62.


