

Local indices wrap week on a quiet note

2,291.73 Semdex Sem-10 425.94 Demex 224.87

The SEMDEX ends nearly unchanged at 2,291.73 (+0.01%), wrapping up the week with little movement Leisure & Hotels: LOTO closes at 52-week low of Rs3.70 (-1.3%) on 75.8k units. amid subdued trading volumes. The SEM-10 edges up by 0.06% to close at 425.94, while the DEMEX dips slightly by 0.03% to 224.87. Total market turnover on the Official Market amounts to Rs25.8m on 1.0m $\,$ shares traded.

Foreign sales amount to Rs6.1m against foreign purchases of Rs1.1m.

Banking names continue to dominate market activity, with MCBG closing flat at Rs424.25, accounting for 61.6% of total turnover (Rs15.9m). Meanwhile, SBMH inches up +0.4% to Rs5.42, on Rs2.1m traded.

Finance: CIM rises to Rs14.55 (+0.3%), MCBG Pref advances to Rs9.70 (+0.8%), MUA declines further to Rs64.00 (-1.5%).


Information, Communication & Technology: EMTEL inches up to Rs20.85 (+0.2%) on 0.1k units.
