

Stock Market Update June 27, 2025

Final stretch for ENL/ROGERS restructuring

Semdex 2,307.35 Sem-10 430.43 Demex 223.91

Value Traded (MVT) for the day amounts to Rs79.9m on a volume of 1.9m shares.

The SEMDEX extends its winning streak for the fourth session, closing at 2,307.35 (+0.1%). Market AFREXIMBANK closes unchanged at USD2.80 with value traded amounting to Rs29.1m, accounting for 36.4% of MVT.

ENL closes marginally higher at Rs29.00 (+0.2%) with value traded for the day amounting to Rs1.6m. After market close, the Group announced that the Supreme Court has approved the scheme of arrangement leading to the creation of two distinct listed entities: NewENLRogers and ENL post-Scheme. The first trading day of NewENLRogers has been set for 09 July 2025. ROGERS was suspended from trading today, with its last recorded price at Rs37.75.

Finance: ABCH declines to Rs18.50 (-1.1%), MCBG closes unchanged at Rs430.00 with value traded of Rs37.7m, MCBG Pref rises to Rs10.00 (+3.1%), SBMH gains +0.4% to close at Rs5.50.


