Commerce & Industry: VIVO edges up to Rs440.25 (+0.1%).

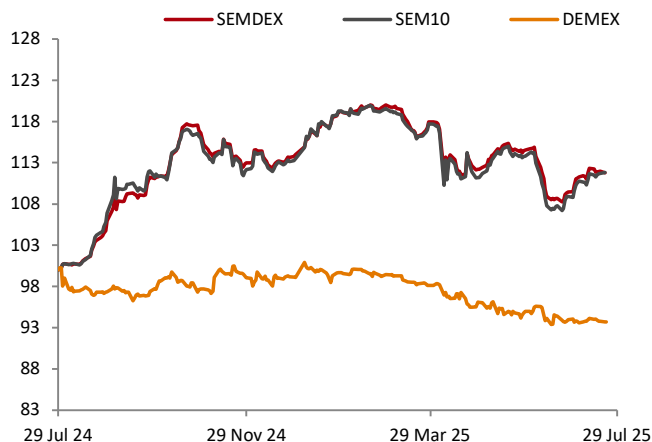
