ENL surges as top gainer

Traded (MVT) for the day amounts to Rs29.1m on a volume of 1.3m shares traded.

Foreign Investors (FI) are net sellers with FI Sales (FIS) of Rs12.8m Rs30.50 (+1.7%). compared to FI Purchases (FIP) of Rs5.0m.

ENL (recently rebranded as Almarys Limited) advances by +9.6% to close the session at Rs6.14, emerging as the top gainer of the day. The stock rebounded after hovering below Rs6.00 over the past three trading sessions. Value traded amounts to Rs3.0m, including foreign purchases of Rs5.6k and foreign sales of Rs24.6k.

The SEMDEX closes in the green territory at 2,451.24 (+0.4%). Market Value Finance: MCBG closes at Rs469.75 (-0.1%), SBMH rises to Rs6.40 (+2.2%).

ICT: EMTEL moves up to Rs21.45 (+0.9%).

Commerce: INNODIS declines to Rs23.50 (-0.8%), IBL advances to


