

Stock Market Update September II, 2025

SBMH hits 52-week high

Semdex 2,452.24 Sem-10 460.29 Demex 223.66

Value Traded (MVT) for the day amounts to Rs40.2m on a volume of 0.9m shares traded.

Foreign Investors (FI) are net sellers with FI Sales (FIS) of Rs14.3m compared to FI Purchases (FIP) of Rs3.1m.

SBMH gains +0.3% to close at a new 52-week high of Rs6.42, marking its third consecutive session of gains. Value traded stands at Rs2.4m, representing 5.9% of total market turnover. At the current price, the banking stock's market capitalization is Rs19.5bn, with a dividend yield of 7.8%.

Finance: CIM moves up to Rs16.10 (+0.3%).

ICT: EMTEL edges higher to Rs21.55 (+0.5%).

The SEMDEX inches up by 1.01 points to close at 2,452.24 (+0.04%). Market Commerce & Industry: VIVO inches up to Rs440.00 (+0.3%), IBL retreats to Rs30.00 (-1.6%), MOROIL inches lower to Rs16.00 (-0.3%), PIM rises to Rs51.00 (+2.0%).


