Property: ASCE inches down to Rs19.90 (-0.3%)

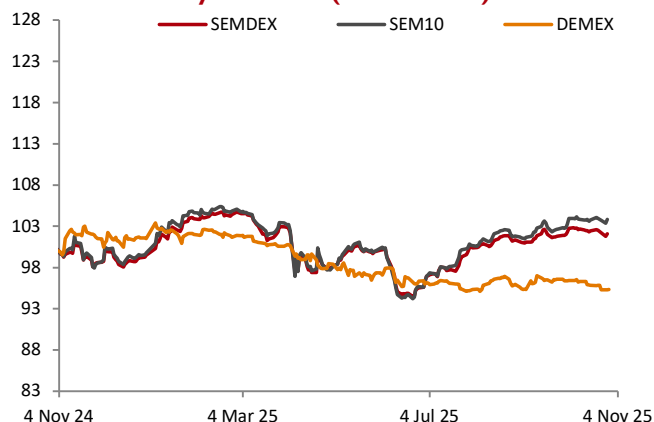
AFREXIM rises to USD2.80 (+0.4%)
