The **SEMDEX** falls by -3.12 points to finish at 2,335.67 (-0.1%). Market Value Traded (MVT) for the day amounts to Rs29.4m. Foreign investors are net sellers with foreign sales of Rs3.0m with foreign purchases of Rs0.5m.

ERL emerges as the most actively traded stock in today's session with value traded of Rs8.3m, representing nearly 28% of total market turnover. The stock closes slightly lower at Rs20.20 (-0.5%).

Finance: **MUA** falls to Rs65.00 (-1.5%), **SBMH** edges lower to Rs6.58 (-0.6%).


