The **SEMDEX** inches up to 2,290.49 (+0.2%). Market value traded remains modest at Rs12.0m.

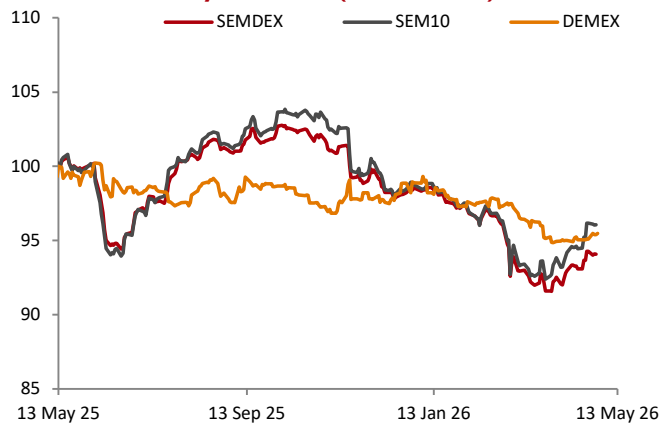
